

Directions to Bridgeport National Bindery, Inc.

From the Massachusetts Turnpike

Take the Turnpike to Exit 6 (I-291)
Take a left after the toll, and follow the signs for I-91 South
After you get onto I-91 South, follow the Interstate 91 Directions Below.

From Interstate 91

Take Interstate 91 to Exit 3 (Rt. 5 North Agawam–Southwick).
You will go over a bridge (Rt. 5 North); Stay in the Right Lane.
As soon as you are over the bridge, take your first exit (Rt. 57).
At the bottom of the ramp, you will be on a rotary; go approximately $\frac{3}{4}$ of the way around the rotary and follow the sign for Route 57 West.
Follow Route 57 approximately 3.5 miles to the Garden Street exit.
At the top of the ramp take a Left onto Garden Street.
Follow Garden Street to the end (approximately .7 mile), and turn Right onto Silver Street.
We are approximately .3 miles from the corner, on the right at 662 Silver Street.

From Bradley International Airport (BDL)

Exit the Airport and follow Rt. 75 North to the Massachusetts State Line.
From the state line go approximately .7 miles (first traffic light in Mass.) and take a Left onto Shoemaker Lane.
Follow Shoemaker Lane for approximately 1.2 miles and take a Right onto Silver Street.
We are approximately .4 miles from the corner, on the left at 662 Silver Street.
